The major strive of our company over its 40 years' history has been to strengthen its position of key factor for the development of the Bulgarian economy who caters for the maintenance and the development of a secure infrastructure in Bulgaria and a reliable partner in the transmission of natural gas to neighbouring countries.

Today in line with our common objective to achieve a liberalized and integrated gas market we work to realise investments which through the

regional cooperation in the area of the development and integration of the energy networks would lead to the boost of the security of supply and stimulation of the cross-border gas trade.

In the context of the European objectives to realise an interconnected and single pan-European gas market the development of the infrastructure in Bulgaria is directly linked to the positioning of the country as a gas distribution hub in Southeastern Europe.

We believe that the interconnections with the neighbouring countries - Turkey, Greece, Serbia and Romania are key to market integration. They will contribute to guaranteeing the supply of natural gas to the country and the region and create the real conditions for the diversification of the sources and routes and the possibility to transport additional natural gas quantities to and across Bulgaria.

For less than half a year we succeeded to commission four modernized compressor stations – the total amount of the investment is more than 200 million Bulgarian levas, thus improving the gas transmission infrastructure in order to continue to work as a reliable natural gas transiting company. Our plans to expand the storage capacity of the currently unique gas storage facility in Bulgaria – Chiren UGS are also directly linked to the development of the gas infrastructure in the region to allow the service of the national and regional market, and the important project for the modernization and rehabilitation of the existing infrastructure for transmission of natural gas intended to increase its efficiency and reliability.

The main projects which our company develops are confirmed by the EC to be projects of common interest and this is in recognition of their importance. The European Commission officially acknowledges six projects of Bulgartransgaz EAD to be an investment of particular significance to the security and the diversification of natural gas supply in Europe and the realization of an integrated and competitive market. These projects are:

- Chiren UGS expansion
- Necessary rehabilitation, modernization and expansion of the Bulgarian transmission system
- Infrastructure to allow the development of the Bulgarian gas hub
- Interconnector between Turkey and Bulgaria
