On the road towards carbon neutrality, energy storage will be key to accommodating variable solar and wind energy into the system. Among available storage solutions, there is currently no alternative to existing long-term energy storage capacities - the electricity ones being limited in scale or only suited for short- or mid-term storage. Making the best use of underground storages should be a policy priority to accelerate the decarbonisation of the energy system and ensure its resilience.

#### Session 1

Within the context of Frontier Economics-Baker Botts' study, GIE have better understood the lessons that could be drawn from the electricity sector in terms of legislative proposals and discussed the market-based regulatory interventions for storage that would enhance energy system integration. Three recommendations have been presented at the 34<sup>th</sup> Madrid Forum:

- **1.** Better coordinated network planning via a greater integration of flexibility options
- **2.** Regulatory incentives aimed at avoiding increasing electricity capacity costs
- **3.** Government interventions as further measures to secure an adequate and reliable energy system

#### Session 2

As energy storage plays an essential role in the decarbonisation of the energy system, its definition has benefited from an updated framework in the Electricity Directive, allowing to introduce Power-to-Gas technologies. In recent months, the publication of several reports has also shown a growing interest in energy storage from an electricity system perspective. While this interest makes sense, examining the question only from this perspective is too limited. In light of the upcoming revision of the 3<sup>rd</sup> Energy Package, **reconciling the electricity and gas legislations on the question of longterm energy storage from an integrated system approach** is essential to adapt to the evolving market conditions and respond to the needs of the changing energy landscape.
